## Interpolation

Suppose one has a set of $N+1$ tabulated data points $\left(x_{i}, y_{i}\right)(i$ goes from 0 to $N)$ that one believes have been obtained very accurately.
What you would like to do is obtain a functional representation which allows one to find a function $f(x)$ which agrees with the tabulated points (often called nodes), but is also able to give reasonable values at non-tabulated points.

When the $x$ value that one seeks falls in the range $x_{0}<x<x_{N}$ the required value $f(x)$ is called an interpolated value.

When the $x$ value that one seeks falls in the range $x<x_{0}$ or $x>x_{N}$ the required value $f(x)$ is called an extrapolated value.

## EXAMPLE

Consider the following application:
We have census data for the United States taken every ten years (in millions).

| YEAR | 1940 | 1950 | 1960 | 1970 | 1980 | 1990 |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- |

| POPULATION | 132,165 | 151,326 | 179,323 | 203,302 | 226,542 | 249,633 |

## Weierstrass Approximation Theorem

If $f$ is defined and continuous on $[\mathrm{a}, \mathrm{b}]$ and $\epsilon>0$ is given, then there exists a polynomial $P(x)$, defined on $[\mathrm{a}, \mathrm{b}]$ such that $|f(x)-P(x)|<\epsilon, \quad$ for all $x \in[a, b]$.

EXAMPLE
4. Recall the previous example of linear interpolation that we went through with U.S. Census Data. Consider the more general problem of having two data points (or nodes) ( $x_{0}, y_{0}$ ) and $\left(x_{1}, y_{1}\right)$.
Write down a formula for the value of the interpolated value $P(x)$ below.
(Do we have any restrictions on the $x$ that $P$ is evaluated at?)

## Lagrange Polynomials

The general form of the interpolating polynomial $P(x)$ of degree 1 through the points $\left(x_{0}, y_{0}\right)$ and $\left(x_{1}, y_{1}\right)$ has the form:

$$
P(x)=\frac{\left(x-x_{1}\right)}{x_{0}-x_{1}} y_{0}+\frac{\left(x-x_{0}\right)}{\left(x_{1}-x_{0}\right)} y_{1}
$$

This can also be written as $P(x)=y_{0} L_{0}(x)+y_{1} L_{1}(x)$, where $L_{k}(x)$ are called Lagrange Polynomials of degree 1 for $x_{k}$. To be precise we should write these Lagrange polynomials as $L_{1,0}$ and $L_{1,1}$ to show that they are Lagrange Polynomials of degree 1 for $x_{0}$ and $x_{1}$, respectively.

So, $L_{5,2}(x)$ would be

5. Let's show that the answer you wrote down to (4.) is the same thing as the form when written using Lagrange Polynomials
6. Evaluate the generic $P(x)$ linear interpolant at $x_{0}$ and $x_{1}$. What values do you expect? Does this happen?
7. What does this tell you about properties of $L_{k}\left(x_{j}\right)$ ? In other words, what happens when you evaluate a Lagrange Polynomial at a node? (Is there a difference whether $k=j$ or $k \neq j)$ ?

In general Lagrange polynomials of degree $n$, are given by

$$
L_{n, k}(x)=\prod_{\substack{i=0 \\ i \neq k}}^{n} \frac{x-x_{i}}{x_{k}-x_{i}}
$$

Using a Lagrange Polynomial of degree $n$ to interpolate a function value $P(x)$ between $n+1$ function values $y_{k}$ produces

$$
P(x)=\sum_{k=1}^{n} L_{n, k}(x) y_{k}
$$

## Error Formula for Lagrange Interpolation

The error between a function $f(x)$ and its interpolating polynomial $P(x)$ derived from the nodes $x_{0}, x_{1}, \ldots x_{n}$ on $[\mathrm{a}, \mathrm{b}]$ is given by

$$
e(x)=|f(x)-P(x)|=\frac{f^{(n+1)}(\xi(x))}{(n+1)!}\left(x-x_{0}\right)\left(x-x_{1}\right) \cdots\left(x-x_{n}\right)
$$

where $\xi(x)$ is in $(a, b)$

## Grouphork

Determine the second degree interpolating polynomial for the function $f(x)=1 / x$ which uses the nodes $x_{0}=2, x_{1}=2.5$ and $x_{2}=4$ to interpolate the value of the function at $x=3$.

In other words, suppose we know that our data at the nodes comes from the function $f(x)=1 / x$, use this information to generate an interpolant for $f(x)$ and then evaluate your interpolant at $x=3$.
(a) First write down the $\qquad$ Lagrange polynomials of degree 2
(b) Combine your answer above to form $P(x)$
(c) Use your interpolant to approximate $P(3)$
(d) How close is this to the actual value of $f(3)$ ? (What is the absolute error made by the interpolant?)
